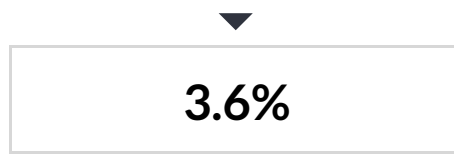
STUDENT PLACEMENT (PERCENT OF TIME INSIDE REGULAR CLASSROOM)



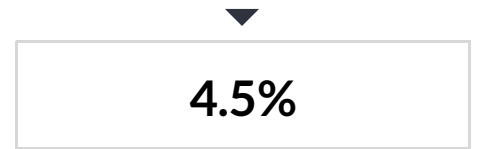

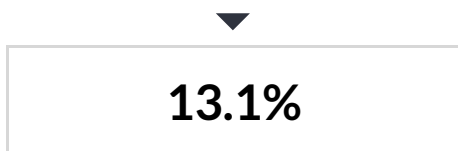

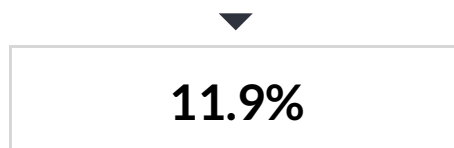

SCHOOL-AGE STUDENTS WITH DISABILITIES CLASSIFICATION RATE

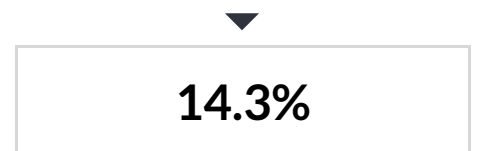

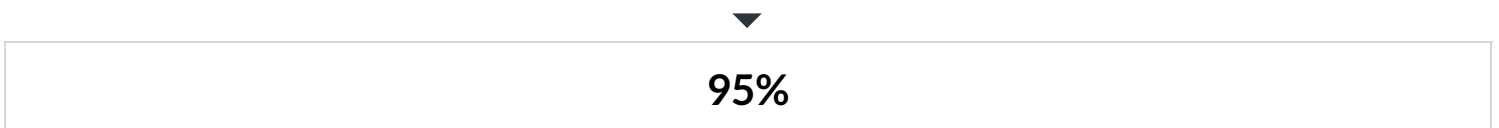

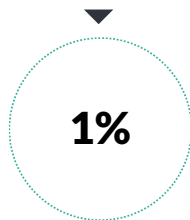

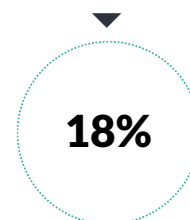

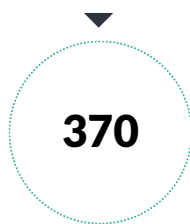

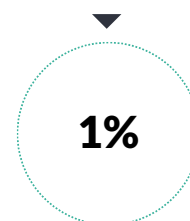
