1. Stormwater Mandated Program

In 2009, the District, under the federal Clean Water Act mandate, executed a Notice of Intent to develop and implement a Stormwater Management Program (SWMP) for the Putnam Central Valley School District (PVCSD) at the High School/Middle School located at 146 Peekskill Hollow Road, Putnam Valley, NY.

During the first year, the District initiated several actions, including:

- Setting up a Stormwater Steering Committee and appointing a Stormwater Coordinator
- Developing a Stormwater Website
- Issuing newsletters and fact sheets on stormwater related issues
- Holding Student Participation Programs
- Conducting Training Programs for O & M Staff
- Developing Storm Sewer Maps
- Adopting Guidance Procedures for Construction-Related Activity and for the Control of Illicit Discharges (nonstormwater discharges)
- Conducting Annual Public Meetings
- Preparing Annual Reports to the State

2. Why Stormwater Matters

Stormwater runoff, containing oils and greases from our roads and parking lots, pesticides and herbicides from our lawns and bacteria from failing septic systems pollute our drinking water and make our oceans unsafe for swimming.

3. Stormwater Survey

As part of the ongoing stormwater program, PVCSD will be conducting a survey on the current stormwater program.

4. Survey Goals

The purpose of the survey is multifold, as outlined below:

- First, to create an awareness in the school community of the actions undertaken by the District, since the initiation of the program in 2009.
- Second, to encourage the school community to learn about the importance of the stormwater initiatives, and the impact of stormwater pollutants on downstream waters such as streams, lakes and reservoirs.
- Third, to obtain feedback from the school community on how to foster a more active school participation/involvement in the program

5. Survey Questionnaire

To prepare you for the upcoming survey, a questionnaire has been posted on your stormwater website.
